Housing & Homeless Service Providers,

I'm reaching out to provide an update on homeless crisis response system funding. Unfortunately, we are still experiencing a major reduction in document recording fees—our budget last year was \$1.4 million and we are estimating those will be **reduced 50% year-over year**. This revenue reduction began last year, and to avoid any mid-year cuts our Board of Commissioners approved \$600,000 of American Rescue Plan funding to patch the budget. That is not an option for this current funding cycle.

We have also been cooperatively planning with leadership from each of our cities and they are aware of the anticipated funding challenges. A leadership team made up of the Mayors and one County Commissioner helped shape the priorities for the current NOFA, and we are exploring options with each city on the possibility of any collaborative funding approaches. Those discussions will continue over the next several weeks. Even with a contribution of city resources, we wanted you to know that we are still expecting a reduction in revenue and increase in funding requests.

Please let me know if you have any questions—and thanks for all of the work you and your staff do to meet people's needs in the community.

Volunteers take part in annual homeless count

A team of 78 blanketed Skagit County on Thursday, looking to count the homeless and help them with some basic needs.

The annual Point in Time Count of the homeless is required by the U.S. Department of Housing and Urban Development.

Though results won't be available until later this year, the count will be used to allocate federal funding for homeless services.

Community Action of Skagit County is contracted to run the Skagit County count.

Steven Simmons, outreach programs manager, said recent counts have tallied about 300 people, but his team is trying new efforts to get a more accurate count.

This year, volunteers with Emmanuel Baptist Church in Mount Vernon invited the homeless to come to the church, be counted and get a hot meal.

Terry Ogdon, the church's director of children's ministry, was one of several members of the congregation preparing chili, bread and drinks for anyone dropping by.

"We're part of the community," she said. "Why wouldn't we want to help the community?"

Other volunteers were stocking up on food and hygiene kits to distribute to those who came by.

Patty Laughlin and Madeleine Anthony, both first-time volunteers for the county Point in Time Count, stopped at the church just after 11 a.m. to grab bowls of chili to take to a group they saw near the Goodwill.

Anthony said one person had clear medical needs, and she offered to take them supplies or help them get an appointment for treatment.

"I think a lot of us aren't far," she said. "One missed paycheck or medical emergency and we can be there too."

Laughlin said shelter exists for those who can pass a background check, but she's concerned for those with felony convictions who usually aren't welcome.

"They weren't sentenced to death," she said. "As a community, we can do better."

Cold reality: Energy rates rise as temperatures fall

OAK HARBOR, Wash. — For Washington residents on low or fixed incomes, cold winter temps and rising energy costs force some to make hard choices.

John Owen sets his thermostat to 68 degrees -- not a degree more -- because that's what he can afford.

"If I turn it up anymore I'm not gonna be able to afford to pay the bill," he said.

Owen and his wife live on a fixed income of just \$1,000 a month.

When they go to bed they turn the heat off and bundle up with jackets and blankets to save money.

"When it gets cold out, it gets cold in here, and the temperature changes rapidly," Owen said.

Owen said his heat bill nearly doubled this month to \$140. He said he's never seen it so high and has had to make decisions he shouldn't have to.

"I have to make a choice," he said. "I have to decide if I going to eat, or am I going to pay my rent and my utilities."

Energy rates up this year

Puget Sound Energy rates jumped by nearly 9% this year while natural gas costs skyrocketed by around 23%.

An early and exceptionally cold winter is giving people sticker shock when they go to pay their bills.

The war in Ukraine along with less natural gas production and increased demand is driving prices higher.

"If they keep raising the prices, how are we gonna afford this?" John asked. "I don't know where it's gonna end."

Utility assistance programs

This winter is creating a "perfect storm" of sorts for agencies like the Opportunity Council, which helps people struggling with rent and utility bills.

COVID relief money to help people pay their bills is running out with the need for assistance higher than ever.

"We do our best to just get really creative, but it is hard on your heart and it is concerning when you know people are really struggling," said the council's Melissa Frasch-Brown.

Community Action of Skagit County provides assistance, as well.

For now, John Owen said he is keeping warm with a pot of beans, hoping for an early spring and brighter days ahead.

"We're just grateful for what we have," he said.

I. CALL TO ORDER

Board President Richard Brocksmith called the meeting to order at 5:00 pm. Introductions. Reminder of our equity-based approach and questions as we work through the agenda.

Division Reports

January Finance Report Through November 2022

Motion to approve the consent agenda including minutes of December 15, 2022 Board meeting and January Finance Report through November 2022 made by Davidson second by Tate, motion passed unanimously.

III. DISCUSSION AGENDA

6. Board Exec and Planning & Engagement; Brocksmith

Welcome to new Board member Carolyn Moulten, appointed to the board in December, and welcome to Danny Hagen.

Motion to appoint Danny Hagen to the 2023 Board of Directors made by Tate second by Bennett, motion passed unanimously.

Richard noted that the Vice-President position is still vacant and recognized Kari Ranten's past contributions in that role, and requested for current members to reach out if they have interest in filling that role.

7. State of the Agency; Henkel

Bill noted that he and Richard attended Cora Steinhauer's memorial; noted she will be missed and recognized her many contributions to the Board and the community. Cascade Landing is slated to begin housing tenants in February. PSE awarded a \$100,000 grant for putting solar panels on the roof at the Mt. Vernon offices, we received \$135,000 Family Resource Center funding, and \$50,000 from PACCAR to support the additional development costs for Cascade Landing. It was further noted that County staff let us know that the Document Recording fees have dropped by about 50%. These funds support housing and homelessness prevention, and there are discussions about the State or County potentially using other funds to backfill. This could have an impact on Community Action programs. There has been a significant spotlight on food insecurity in Skagit County, including at the last LAC meeting, when Morgan Curry from Skagit Gleaners shared her research on migrant farmworker food insecurity. Today was the annual homeless Point in Time Count. Bill also noted that Sandi is part of the county's "North Star" advisory group, and said that in future meetings we may want to learn and discuss this effort, as its eventual findings will likely guide future local efforts to address homelessness and behavioral health issues.

8. CREAT; Boucher, Soltero, Jennings

Thomas spoke briefly on how CREAT ("Community Relationships Education and Advocacy Task Force") originated, as a vehicle to focus and amplify our organization's advocacy on behalf of our community and the people we serve. To do this, CREAT focuses much of its efforts on building relationships with and educates our local, state and even federal elected officials and other community leaders. Liz noted that the Latinx Advisory Committee (LAC) works side by side with CREAT to provide information on needs and advocacy for those with lived experience. Both Kati and Christina noted the importance of being able to serve in this capacity and be at the table, to learn and bring that information back to the community. Thomas and Liz reviewed the recommendation that the Board review and understand the 2017 Public Policy Advocacy Procedures that provides guidelines and structure as to how we, as an Agency, can advocate for legislative priorities for the Agency and our partners. These guidelines give guardrails for staff, while allowing staff to respond quickly as advocacy needs arise – as well as when to reach out to CREAT and the full Board for guidance, and in some cases, such as where there is potential "heat," for approval. Further discussion on two specific statewide priorities for Community Action, as recommended by CREAT and staff. The first is ensuring ongoing State match for Community Services Block Grant (CSBG) funding. This is flexible funding and essential to provide quick, innovative responses to community need, and has a special focus on serving rural and BIPOC communities. Last year, the state association was able to secure a full state match to the federal level of funding for the first time, which provided significant funding to Community Action (approximately \$250,000), and supported our services to east county, our work helping to host and coordinate the LAC, and WIC

staff outreach and service to the farmworker community. Last year was a special "Proviso" allocation. This year, in creating the State biennium budget, we are working to make this funding permanent. Our second priority is our Community Projects direct legislative capital funding request, which would provide \$300,000 for the purchase and a portion of the pre-development costs for our purchase of the Kulshan View property in Mount Vernon. Liz noted an "Advocacy 101" Training coming in February; attendees will be invited to meet with their own legislators and that additional advocacy options will be presented as the legislature works through session.

Motion to endorse Community Action of Skagit County's 2023 state advocacy priorities made by Ortiz second by Bennett, motion passed unanimously.

9. Housing Work Group; Brocksmith, Davidson, Metcalf

Richard provided a brief overview of the potential project located at Kulshan View in Mount Vernon—potentially 55 units, currently envisioned as 2-3 bedrooms, because of its proximity to schools and other multi-family apartments. If we proceed to purchase, we would refine the design and layout, based at least partly on the population we intend to serve there. Noted that we have gone through feasibility study over the past six months including land use, wetlands study, preliminary design and, this week, a pre-application with the city of Mount Vernon, which we believe is the last step in our feasibility process. Based on the input we received from city stuff from this pre-app, and all other review, there appears to be a path forward on a future development of that property. Our consultants, our Housing Work Group, and our Board Finance Committee are recommending that we purchase the property. In addition to all of the feasibility study, thorough review by the Finance Committee indicates that the Agency is in a position to acquire the property. A combination of funding from cash held in different agency accounts would allow for the purchase without tapping into operational funds. We have also already invested about \$20k into ensuring the feasibility of the project. There is potential for additional funding and partnerships moving forward.

Motion to approve the purchase of the Kulshan View property in Mount Vernon as a site of a future housing development made by Tate second by Davidson, motion passed unanimously.

Brief discussion about purpose of the MOU between Cascade Landing LLC and Community Action.

Motion to approve the Memorandum of Understanding (MOU) between Cascade Landing LLC and Community Action of Skagit County made by Davidson second by Bennett, motion passed unanimously.

Michele provided a brief overview of the Cascade Landing Advisory Committee to help track occupancy, and to navigate tenant issues that may arise at Cascade Landing. Details are still being hammered out but the desire is to have a Board member liaison on the Committee. Tina Tate has volunteered to fill that role!

Donor Development; Bennett, Prud'homme

Kate talked briefly about Spirit of Hope on March 30, an event she summarized as "Small plates; big hearts." The event will focus on sharing our programs and the broad reach of the agency as a whole. At she began, 11 of 25 tables had been sponsored. Carolyn and Kati each offered to sponsor a table, getting us over 50% of tables sponsored! Kate requested Board members reach out to "new" people who might have interest in the agency. Philip noted that the registration portal is open now and special information will be provided to the Board to reach out to their networks. In addition to our table sponsors, we are very close to our event sponsorship goal of \$25k.

January 2023 Division Director Report – Melissa Self

Care Coordination

Kathleen Morton, Care Coordination Admin Manager / Jazmin Flores, Care Coordination Manager Accomplishments:

- Our Housing team has continued to adapt to the changes with Care Coordination and learning
 the Coordinated Entry process in order to integrate intakes into their schedule once per week to
 assist with the increasing demand for services.
- Housing Staff have completed their core curriculum to Housing Case Management as well in order to better support with Care Coordination services.
- Seeing more engagement in staff going out into the field and holding home visitations.

Challenges:

Adapting to change in our service delivery model is a huge shift and challenge for our staff as
they get to know their new roles. Managers are providing support as best we can right now, in
addition to having regular meetings with the rest of Care Coordination team to iron out
questions and details that come up.

Emerging Issues:

As we see January come to a close, we face some complications with our new service delivery
model when it comes to capacity. We have had 3 Eviction Prevention team members leave our
department due to the changes of Care Coordination and another staff member due to
performance issues. We have positions open for our direct service team however, we lack
sufficient applications to fill these vacancies and meet the demand for services. Currently we
have 60 households waiting in our referral queue for services—creating a bottlenecking affect.

Street Outreach

Steven Simmons - Outreach Manager

Achievements:

- Continuing with SRNP roll-out and development- caseloads filling up, posted for new CM.
- Presented SRNP to the County Crisis Negotiation Team, an inter-agency law enforcement group
 that works with individuals who are experiencing crisis and creating dangerous situations for law
 enforcement. This went extremely well. They suggested some great edits to the SRNP referral
 form, which were adopted.

Challenges:

- Short-staffed.
- Transition to SRNP has been difficult on team in some ways. They see a drop in sheer numbers
 of clients served, and have not been working with their CM clients long enough to see some of
 the benefits of long-term, individualized attention and work.

Emerging Issues:

• Catholic Community Services/MVPD motel program set to expire soon, Friendship House hotel vouchers running out, Winter shelters set to close soon, day shelter funding expiring. We will

soon have a ton of clients adjusting to not having anywhere to go. Our hope is to have some folks hired on soon to increase our regular outreach capacity.

Resource Center/Coordinated Entry

Dulce Vasquez, Resource Center Manager

Skagit County's North Star project has been studying the countywide homeless system and did not include the Coordinated Entry funding in their current NOFA. They have instead, extended our current contract that would have expired on June 30,2023 to December 31, 2023. We expect to be included in conversations over the next several months to hear the committee's concerns and recommendations. We will apply for the next round of funding when they release the NOFA in fall 2023.

In preparation, we are gathering and preparing information related to the Homeless Coordinated Entry System, including challenges that we, our partners, and clients have identified, and responses we have taken to try to minimize those challenges. **Please see item # 9.**

What accomplishment are you most proud of?

DSHS mobile truck coming to Concrete and assisting over 40 people in January with basic food or with Health Care signup. This immensely helps with the food insecurity and lack of Heath Care in East County. Hamilton outreach numbers are growing as we are consistently there twice a month and offering DSHS assistance, housing intakes, energy referrals, critical need vouchers and bus passes.

What challenge are you currently facing?

We continue to see a need for assistance for our elderly in the Upriver Community. They are in need of a vast array tasks from running errands to just someone to come and visit them for an hour or two. Another challenge is the fact that we are perpetually understaffed in East County and my staff is facing burn out rapidly.

What emerging trends, opportunities, or threats are you watching?

Opportunities: Partnering with the library to offer educational programs can bring so many more opportunities to residents in East County and assist people with becoming employed. Emerging trends and threats to our community: The continuing fast rising cost of goods and utilities is making it difficult for almost everyone to make ends meet. We are seeing an increase in need for emergency food, basic food assistance, rental/mortgage assistance and energy assistance. Threats that we are seeing: Continued need for long-term mental health care/rehabilitation facilities. If we don't address the reason why these people are in the situation they are in and get them the proper care, housing them will do little to no good and we will continue to see a multitude of problems.

Employment and Education

Marissa Davison, Employment, Education, and Financial Skills Manager

What accomplishment are you most proud of?

There has been a lot of collaboration between employment and housing recently which has helped in receiving and serving to incoming FCS clients. We have established a new system to track participant activities which have improved compliance with the WorkFirst guidelines.

Note from Sandi: One accomplishment is promoting Marissa to Manager, which will help us build the education and employment programs, but also help smooth out some supervisory challenges on the Adult Education side.

What challenge are you currently facing?

Ideally, we would like to add an additional class on for participants to have an opportunity to make up missed hours or complete the rest of their required activities, however, we currently do not have the hours or capacity to add an additional class.

Note from Sandi: One challenge in Education are staffing difficulties due to health issues and communication consistency.

What emerging trends, opportunities, or threats are you watching?

The switch to care coordination will potentially bring an influx of employment client which is a great opportunity to expand our program.

Energy and Utility Assistance

Misty Velazquez, Energy and Utility Assistance Manager

What accomplishment are you most proud of?

The amount of clients still calling to schedule appointments, we are currently scheduling in April. No shows are not happening as much as in past, which is showing us the need is still really high in our Community.

What challenge are you currently facing?

Not really facing any challenges at the moment.

What emerging trends, opportunities, or threats are you watching?

Lots of Outreach opportunities are presenting themselves, but they are after business hours. This makes it very difficult to staff these opportunities due to staff family situations and schedules.

Board Report 2/15/23

Skagit Food Distribution Center

Community Resource Manager: Madeline McGonagall; Community Resource Coordinator: Jessica Espy

Accomplishments:

- Hired Madeline McGonagall as the SFDC manager and she has been onboarding wonderfully
- Working on a comprehensive operations manual and cross training plan for staff
- Completed the walk in cooler project and received an 'exceptional' grade on the Food Lifeline Grant compliance. Only need to still purchase the refrigerated box truck
- Scheduling an 'introductory tour' for Madeline and Jessica to meet-and-greet all food bank partners in order to improve relationships and inform the SFDC what each partners' unique challenges, barriers, needs and client services are. The intention is to tailor technical assistance and communication strategies to each entity.
- Working with Morgan Curry of the Gleaners to support their capacity building and expansion as well as becoming a new TEFAP/EFAP food bank partner with an open service day.
- Developing purchasing plans from 4 funding sources to spend out the remaining ~\$40k for local food purchasing before the end of grant term including ~6000 units of locally produced meat.
- Creating a donor development plan with Philip to do more targeted outreach to commercial and wholesale food distributors and producers with the hopes to pull more donations like the January gift of \$10,000 cash and \$15,000 in poultry product for local food banks
- Evaluating our (T)EFAP subcontractor roster—renewing current contracts and offering expanded services to partial contract holders (such as the 3 San Juan Island food banks) or very small food banks who are currently operating solo (South Whidbey). Restarting quarterly Food Bank Subcontractor Meetings and supporting the Food Bank Association as a separate entity.

Challenges:

- There has been a lot of change at the SFDC in the past year so learning how to support and engage staff as the SFDC is in a rejuvenation and growth process has been essential
- The Senior CFSP box program has lost volunteers and clients over the pandemic. We have a new flyer and outreach strategy to recruit for both needs
- Food resource availability, diversity and funding is dwindling so we will need to be creative Emerging Issues:
 - Emergency Food Resources are not currently being held, and the SFDC facility would not have the capacity to hold a sufficient volume to support the full needs of food bank clients in the event of a natural disaster or other sudden, high volume need. External partnerships will be required to address this substantial need
 - Farm and Food Grant Season is upcoming so we will need to accomplish previous outcomes and apply for new, expansion or service funding opportunities.

Vets Connect

Veterans Services Coordinator: Carmina Villalobos; Veterans Services Liaison: Vernon Hunter

Accomplishments:

- Philip applied for a \$20,000 Skagit Community Foundations Grant
- Working towards applying for a \$50,000 Bob Woodruff Foundation grant in May
- Have been working with Megan on Empower Data Entry efficacy, that more comprehensively captures services and touchpoints, with a companion exit survey for this work.
- Vets Connect and Cascade Landing developed the VAF Veteran Housing Subsidy Program enrollment procedures and process.
- Enrollment is open for Cascade Landing and the team is primed to serve the clients as needed Challenges:
 - The SSVF program decided not to hire a new program manager for the Vets Connect office. Therefore, we are deciding how to use the empty office space

Emerging Issues:

- Susan Brisby will officially retire from the Veteran Affairs VASH program in November 2023. However, Kelly Blau (VASH) will continue to partner with Vets Connect.

Mount Vernon and Whidbey WIC

WIC Manager: Wende Dolstad; Mount Vernon WIC Site Supervisor: Jhaveena Broadnax

Accomplishments:

- We are piloting a new online nutrition education program for State WIC. Congress did pass a
 continuing budget resolution containing the increased cash value benefit for fruits and vegetables,
 although programing has not yet added the extra to family benefits. FFY 2022 saw a 10%
 increase in participants over FFY2021.
- Creating the SOPs necessary to distribute the \$15,000 of infant formula awarded through the SFDC partnership WSDA Resiliency Grant. Will have this work completed by term end
- Supporting two staff RD students to receive tutoring to pass their exams which will not only improve their skillsets as assets to the program but also assist with one retiring RD vacancy

Challenges:

- Lack of diapers for our WIC families.
- WIC family liaison on leave for a month.
- Formula availability is becoming more of an issue again.

Emerging Issues:

• WIC will soon be adding lead screening to certification appointments.

Senior and Disabled Services – In Home Services and Medicaid Transport

In Home Services Coordinator: Mariana Brandt; Medicaid Transport Coordinator: Nikki Robinson

Accomplishments:

- Mariana "I am definitely proud of the fact that we were able to maintain some level of transportation services, and also direct services in general, while implementing safety procedures and protocols throughout this pandemic. We have had zero exposures to COVID between our participants and our volunteers, and we aim to keep it that way, while providing needed services."
- Theresa, the new intern started this month and she is onboarding wonderfully! She is also applying for a permanent position with CAS as a Care Coordinator.
- Nikki and Mariana have worked together to develop a handful of outreach flyers to recruit clients, interns and volunteers accordingly.
- Mariana led a great Firewood Cutting Work Party to wrap up that program and move the remaining resources off of private land and onto clients' homes in need of firewood.

Challenges:

- "We were hit with a very large decrease in volunteers due to the pandemic and shifts in staffing, so we are currently working on recovering from that. The biggest ask and the biggest challenge to fill is housekeeping assistance. There is a shortage of caregivers, and many seniors and adults with disabilities reach out for this assistance. Also our program going from 2 staff members to 1 has come with its own challenges."
- Nikki has been incredibly flexible to schedule off hour trips when requested but she would like to be able to offer more consistent, high paying trips to volunteers.
- The budget continues to be a pressing concern we are finding creative solutions and pursuing a variety of funding opportunities to support the program's financial needs.

Emerging Issues:

• Definitely keeping an eye out for any changes regarding COVID, and how that might impact our program. We are seeing a bit more interest in volunteering and I believe that is a trend that I will continue to see.

Housing Projects Director Report

Michele Metcalf February 2023

Cascade Landing - Burlington, WA

Cascade Landing passed the final inspection needed from the City of Burlington Fire Marshal and the Certificate of Occupancy was issued on February 14. There is a small list of items to wrap up at Cascade Landing (primarily exterior work) that is scheduled to be completed before the end of the month.

Property Management activities during the month of February has been focused on screening applicants and working with Community Action programs to line up tenants for occupancy. There are a handful of applicants that meet the rental criteria. The first round of tenants will start occupying units at Cascade Landing beginning the week of February 20.

Kulshan View - Mount Vernon, WA

January was focused on wrapping up the feasibility analysis on Kulshan View. A pre-application meeting was held on January 24 with City Planning staff and Community Action staff, Board President, and project consultants in attendance. City Planning staff confirmed that the request for rezone from R-3 to R-4 falls in line with the Comprehensive Plan and expressed general support of us moving forward with the project.

Community Action moved forward with the acquisition of the property on February 7.

Next steps for Kulshan View include community and neighborhood planning to identify community need to influence our final design plans for unit sizes, unit mix, and configurations. We have plans to engage with the Mount Vernon school district and explore other partnerships, and identify project funding.

Housing Work Group

Prior to the February 3 Housing Work Group meeting, Jason Easton who was nominated for HWG Chair, has decided to decline the role and step away from the committee. During the February 3 meeting the group reviewed the amended memo from the City planning office and revised site plan provided by Mel Maertz, M2 Architects. Discussion focus for Kulshan View also included creating a draft project timeline and list of next steps, which involves submitting the rezone application to the City.

The next Housing Work Group meeting with the full committee will be held on February 17. The HWG will meet again on March 3 and 17.



Breakdown of Funds





2. Add Backfilling Document Recording fees to Community Action of Skagit County's 2023 state advocacy priorities

<u>Background on Discussion Agenda Motion</u>: Revenue from Document Recording Fees, a major source of both local government and state support for homeless prevention, has dropped approximately 50% across the state, as well as in Skagit County. This downturn in revenue is due to a sharp downturn in the

housing market and housing sales/refinancing. This translates to approximate \$160 million less in statewide funding for homeless prevention (while Skagit County's funding will drop from \$1.5 million/year to approximately \$750k). Not only will this be a direct and substantial impact on many of our services to address homelessness, it may also have a multiplier impact of reducing other local sources of housing and homeless prevention funding, such as the new 1590 funds in each city, if those local funds are used to backfill this traditional funding source for homeless prevention. Staff is thus recommending that the Board consider adding this to our other two current state-level advocacy priorities (supporting our \$300k Local Community Projects request for Kulshan View, and the statewide \$15m request for CSBG funding, focused on addressing poverty in rural and BIPOC communities).

HOT TOPIC

New enterprises and Revenue. The County has signaled a 50% drop in document recording fee funding (from about \$1.5 million down to \$750k locally for Skagit), which would significantly decrease services and support for our agency's and our partners' homeless prevention efforts. We are closely tracking efforts in Olympia to potentially backfill some or all of this approx.. \$160m funding drop combined local and through statewide housing and homeless grants.

Recent Progress on Strategic Plan

<u>Better Lives</u>: Procedures for the new service delivery model of Care Coordination are in place, and staff are working out the kinks and learning. More FCS Employment referrals are coming in.

<u>Stronger Communities</u>: We have hosted events with partners on food insecurity, the WFTC, and legislative priorities. Have begun to have conversations with other local partners around a community needs assessment, and have started the planning for 2023 implementation and reporting.

<u>High Impact Organization</u>: Making efforts to find a DEI consultant to help us develop our DEI strategy.

Service Highlight

On MLK day, our Senior and Disabled Volunteer services organization a group of AmeriCorps volunteers to load and deliver 4 truckloads of firewood - 3 to the Concrete area, and one in Clear Lake. There are two rows of firewood left.

Trends in Needs and Services Coordinated Entry is a state- and federally-mandated system of assessing and serving people experiencing homelessness across an array of partners, and following common ways to prioritize services by a measure of "vulnerability." In Skagit County, we are currently the designated Coordinated Point of Entry, though our community takes a "no wrong door" approach across all partners. This ranking is based on a comprehensive intake and assessment.

Though there are several challenges to Coordinated Entry in a community that currently has relatively few tools to house and support people who have severe behavioral health issues, Community Action has already instituted a number of efforts to increase access for experiencing a crisis of homelessness. This includes expanding hours, conducting intakes on the street and in cold weather shelters through our Outreach program, rotating in Care Specialists to support our Coordinated Entry team. See item 7 for a full list.

SUMMARY: Community Action supports policies that advance:

- **Housing** people in Skagit County can afford.
- Food, nutrition and food distribution and food bank capacity-building.
- Basic needs, and resources for families facing poverty.
- Equity for BIPOC and rural communities.

PRIORITY AGENDA:

Community Services Block Grant (CSBG) State Match:

- Washington State Community Action Partnership is asking for a \$15,450,000 match to federal CSBG funding (Community Services Block Grant), which provides flexible funding for the state's 30 Community Action Agencies to respond to pressing (and quickly changing) community needs, including, with a focus on BIPOC and rural communities.
- Community Action of Skagit County serves lower-income residents in the 10th, 39th and 40th Legislative District. We received \$250,000 in 2022-2023 CSBG state match proviso funding to achieve these goals:
 - East County Resource Center, a front door to services for rural folks in the 39th District disproportionately hit by poverty; and our Concrete Meal Program, serving 50+ seniors and families daily.
 - Expanding WIC (Women, Infant and Children Services) to Mixtec- and Spanish-speaking farmworker families, ensuring kids get a good start in school and supporting important Skagit agricultural businesses.
 - Building on the nationally-recognized success of the Skagit Latinx Advisory Committee and Latinx COVID Prevention Team, building bridges between people with lived experience and their elected officials and other decision-makers.

Community Projects Application: \$300,000 for affordable housing development in Mount Vernon:

- Rep. Alex Ramel (40th District) invited us to submit a Community Projects application after we get through our January 24 pre-app meeting with the City of Mount Vernon.
- The funding would cover the 1.5 acre land purchase (\$200k) for the Kulshan View property in Mount Vernon (near LaVenture Middle School), as well as a portion of our pre-development costs (currently estimated at \$575k, including \$375k in wetland mitigation and soil stabilization).

SUPPORT AGENDA FOCUS AREAS:

- Housing & Homelessness: Address the up to 50% decline in funding for homelessness prevention with General Fund dollars. The state's document recording fees are experiencing an almost 50% reduction and the state must take action to fill the gap to prevent a loss of critical homelessness services, especially given the increased need across the state.
- Food & Nutrition: HB 1984: Keep local emergency food system infrastructure strong and address the food shortage crisis. Provide support for food distribution centers, food pantries, SNAP produce match programs, and senior nutrition programs.

Skagit County Homeless Coordinated Entry System Challenges and Responses

Skagit County's Coordinated Entry System is currently funded by Skagit County and is housed at Community Action. The Housing and Resource Center serves as the main point of entry for households that are experiencing homelessness or are at-risk of homelessness.

Each household that calls, comes into our Housing Resource Center, or is met in the community by one of our staff or staff at one of the participating local homeless providers, is interviewed and assessed using a community based assessment that captures the household's vulnerability which will help the provider determine the order in which people are referred to the different local interventions.

Community Action of Skagit County currently uses WA State's mandated database, the Homeless Management Information System (HMIS), to refer households to multiple interventions at a time, and all providers that are participating in the Coordinated Entry System are receiving daily reports of clients who are on our Housing Interest Pool and likely eligible for their particular program.

Coordinated Entry providers are required to serve households based on the household's vulnerability score. At this moment we have 303 households currently enrolled in the Housing Interest Pool who are actively being referred to shelters, rapid re-housing rental subsidy programs, permanent supportive housing programs, and other housing programs and local resources.

Community Action of Skagit County currently holds a diverse set of program funds which are required to go through our Coordinated Entry System – from July 2021-June 2022 we referred 1,161 households to housing interventions and enrolled 1094 households to a housing intervention program. During the same time, period King County referred 597 households and enrolled 285 households to a housing intervention program. King County has a much narrower focus and higher threshold for who is eligible to enter their Housing Interest List.

We acknowledge that the current Coordinated Entry system has its challenges, and the following are steps we are taking to address those challenges.

Challenge: Access to the Coordinated Entry System **Response**:

- Trained multiple services providers (Catholic Community Services, MVPD Outreach Services, Lifeline Connections, etc.) as well as our Street Outreach team and our Care Specialists, on completing the CE assessment.
- Care Specialists dedicate time in their schedule to provide back-up to Coordinated Entry in the Mount Vernon office. And are able to conduct intakes in the field.
- Once we are able to increase staffing (hiring in progress) will open 5 days/week.

Challenge: Lack of Affordable Housing in Skagit County **Response:**

- Community Action has stepped into Housing Development with Cascade Landing, and is nearly ready to begin leasing.
- Catholic Community Services is scheduled to open their new Permanent Supportive Housing complex, Martha's Place in April 2023.
- Although our community lacks housing availability, our agency and other providers have managed to house or find alternative housing for our vulnerable clients using our Coordinated Entry System.
- Beginning in January 2023, we started connecting people to a Care Specialist at the time, or shortly after receiving a CE Intake and being placed on the Housing Interest Pool to connect and assist with navigation of local resources.

Challenge: Lack of Movement on the Housing Interest Pool **Response:**

- Immediate connection with a Care Specialist to work with the individual or household to identify and break down barriers to being stably housed even if they do not rise to the vulnerability score to receive a referral to a housing or shelter intervention, or an intervention is not available.
- Care Coordinators work with the households to connect to physical and behavioral health providers, assist with mainstream benefits such as SNAP or TANF, and connect to resources from Community Action and with local providers. Other communities have had great success with this model of service and have been able to secure housing for households often diverting them from shelters or rental subsidy programs. We look forward to being able to report the same successes as our neighboring communities.

It is also important to note that Coordinated Entry system adheres only to the HUD definition of literally homeless or at-risk of homelessness (must have an eviction notice) and does not recognize families who are living in a doubled-up situation, the farmworker population, or those who are being pro-active and know they will be in a housing crisis situation in the near future.

We continue to monitor the program by listening to clients and community partners, and continually assess the data and outcomes to determine ways to improve access and the experience of those dealing with a housing crisis.
